## Enrollment and Reservation Agreement for 2019-2020 ("Agreement")

To reserve a place in the School and enroll your child for the 2019-2020 academic year, please sign in duplicate and return both copies with the annual registration fee shown below ("Annual Registration Fee") to the School. The School will return to you one countersigned copy.

Sibling Discount: Full tuition applies to the first child, other siblings receive a **\$350 discount off the last payment**.

Upon receipt of the Annual Registration Fee and this Agreement signed in duplicate, the School will reserve a place for the Student named above and provide educational services to the Student during the **2019 - 2020** academic year. The Annual Registration Fee covers most classroom supplies and books; occasionally parents will be asked to donate supplies for special projects. This fee is not refundable. This fee is a minimum payment regardless of when the student is enrolled and is not pro-rated. I (the Parent) understand that I may cancel this Agreement only by providing written notice to the School prior to **June 1, 2019** and that the Annual Registration Fee will not be refunded.

In consideration of the School's acceptance of this Agreement, I promise to pay to the order of the School, the Annual Registration Fee and the Annual Tuition stated above, in accordance with the tuition payment option selected, on or before the due date(s) specified in this Agreement, less any applicable discount(s) as stated above. **Based on the payment option selected, and any applicable discounts, the specific amount(s) and due date(s) of my (the Parent's) payment obligation under this Agreement are:**

**I agree to volunteer for 15 hours per school year (per family) or to pay the school the equivalent \$150.**

I also agree to pay the School's costs, expenses and fees incurred in enforcing this Agreement, subject to applicable law.

A student whose tuition payments are not current as of **June 30, 2019** will not be permitted to begin attending classes until the amount past due is paid in full or satisfactory payment arrangements have been made with the School's Director. A student whose tuition payments are not current as of the last day of any subsequent month will not be allowed to continue attending classes until the amount past due is paid in full or satisfactory payment arrangements have been made with the School's Director. A late charge of \$50 will be assessed on overdue payments.

I understand that the teacher's salaries and the School's overhead expenses do not diminish with the departure of students during the course of an academic year and that my obligation to pay the full Annual Tuition is unconditional after the School's acceptance of this Agreement, or **June 1, 2019**, whichever occurs last. I also understand that no portion of the Annual Tuition paid or outstanding will be refunded or canceled even in the event of absence, withdrawal, or dismissal for the Student named in this Agreement. However, if the Student is unable to complete the academic year because of a serious hardship (for example, job loss or major illness) or if the Student's family relocates a considerable distance from St. Petersburg, FL, then on written request the Director will review the circumstances. Based on its review, the Director may, or may not, in its complete, sole and final discretion, decide to modify with a 60 day notice the Parent's payment obligation under this Agreement. I also understand that this enrollment agreement covers enrollment for the stated classroom for hours on this contract for the full school year. Children will not be moved to different classes during the year.

I agree to release and hold harmless, the School and its Director, other employees, officers, trustees, agents from any and all claims, damages or other liabilities for injuries to the Student named in this Agreement, except for injuries that are the result of gross negligence by any Released Person. I also agree to indemnify the School for any damages caused by the Student.

I accept the rules and regulations adopted by the School as stated in the Parent Handbook, as revised and updated from time to time. I agree that the student may participate in all School activities unless I give the School written notice to the contrary. The Student's disregard of the rules and regulations of the School may be deemed sufficient cause for dismissal. I understand that the School is committed to building positive and mutually respectful relationships through which the Parent(s) and the School work towards the Student's best interests. If this is not possible, the School may require a family to withdraw the Student. The decision of the School in this will be final.
